St. Paul downtown airport Annual Sound Study

- Local airport authority
- Airport advisory council Damien is on the council
- Annual sound study with monitoring equipment in depth overview of noise metrics. Studies began in 2007 and represent 7 days of data collection. A monitor is placed in each district 1-6.
- Aviation Environmental Sound Tool is a modeling tool that determines the number of events produced by aircraft versus community noise events such as a lawnmower.
- FAA regulates aviation impact
- FAA will likely update metrics
- Metroairports.org has events coming up for education on aviation

Urban Design - new public plaza at Salvation Army

- The Salvation Army owns a couple lots west of their building at Lawson and Payne Ave and they would like to develop a park shelter with a farmer's market. The goal is to create a community resource. All contingent on fundraising.
- The next step is to submit the site plan to the city. It is possible to begin construction this fall and finish construction next spring 2024.

Motion to provide a letter of support to the city by Lynette seconded by Justine. Damian would like to make sure there is community input by the closest neighbors. Reier has concerns about a private park and public access. Any concerns about the park should go through Jack.

Land Use - application for rezone and variance for a garden center business 627/629 Bush

- Along the train tracks and active railway to bring a landscape architecture business to the eastside including gravel, mulch, soil and possibly plants if the variance can be secured. Kingscapes also does a lot of design and concrete work.
- Want to rezone the entire space to one zone rather than the current three zones. They have secured 70% of the neighbors' signatures. They are seeking a letter of recommendation from the council. Janey motioned and Emma seconded.
