3. City of St. Paul ADA Transition Plan, Maya Sheikh, Mobility Planner,

Transportation Collaborative & Consultants

Through Public Works

Currently- gathering data about peoples' experience getting around St. Paul, using data to find various points of concern, prioritizing five specific communities

Lynette- shared her experience of living with a disability, ADA compliant housings, downtown St. Paul

Janey- ADA complaint snow removal issues around sidewalks and streets

Tim- how do we hold landlords and business owners accountable who never remove snow/meet ADA requirements

Patricia- what is the role of the survey- accessibility vs mobility?

A: Both- things that fall under public works purview

Janey- what is public works purview?

Maya- sidewalks, streets, crosswalks, paths, public works buildings

This ADA Transition Plan is just for Public Works, not the entire city.

Damian makes a motion to include the talking points of this discussion in our district plan so the government understands the needs of our community in regards to the ADA. Anna-Marie seconded, unanimously approved.

- 4. New Business Welcome: Mary Vang, Smok'N Outdoors BBQ,1409 Arcade St.
 - closed since May 2024, have not opened back up
 - Here to ask for our opinion and support
 - Started as a food truck in 2018
 - They will be closing- haven't announced to the public but she is looking for the ideas to keep the business alive
 - Current thought- market day on Saturdays, market nights on Thursday and Friday nights, has a valid kitchen license
 - Looking for advice and resources from us
 - They are keeping the food truck. They have a lease for the next two years.
 - TAG Cafe is now closing (1440 Arcade St)

Rebecca- loves the idea of keeping the building alive and supports the market idea, different venue, great space: has parking, awnings

Lynette- already talked to her, support our BIPOC community, building could support popup kitchens, could host parties/events, Airbnb style for the food truck

May yer- will share contact info for HAPs business development team, and East Side business networks contacts

Ramona- her church and other nurses always looking for spaces for "fairs", Ramona is crafty and she could sell her crafts there

Jack- Arcade is being redone next year but we are trying to support businesses

Lynette- reapply for the Promise Act and try to get second round funding

Damian- revise business license to ensure you are still compliant.

They had a fire in May and the building was condemned. Currently working with city to get it un-condemned

Patricia- there are lists for commercial kitchens that you could be added to Everyone lends support, she will be back next month
